Report in Brief

The District is applying for grants to further its mission for its citizens and to provide information to help guide future decisions. Item 1 is to provide funds for an acquisition in Butte Creek Canyon (recreational facilities and programming has been a long time identified goal for the District). Item 2 is to develop a feasibility study, conduct outreach with citizens, and develop partnerships to explore recreational opportunities around Lake Concow. Project Narrative

July 15, 2022

The project involves the purchase of approximately 20 acres of Sierra foothills land surrounding about 2000 linear feet of Butte Creek and associated riparian and upland habitat, containing several existing structures that can be readily repurposed for a variety of public uses. There is little legal public access and therefore ability to intimately enjoy the exceptional environmental and historic values in Butte Creek Canyon. This project, along with preparation and implementation of a management plan under a subsequent planning grant, would thus provide for the preservation of and carefully managed public access to this unique area.

As no physical impact to the environment would occur with purchase of the project site, a categorical exemption per Sections 15316 and 15325 of the CEQA Guidelines is being submitted with this application, along with a Phase I Environmental Site Assessment, survey and title documentation, and a current fair market appraisal.

An initial study to determine the scope of environmental review and any necessary mitigation would be prepared for the subsequent management plan which would be developed with full public input. That initial study would assess potential impacts resulting from public access and maintenance of the property under the management plan.

Project Narrative

Over the past 30 years, the Concow Basin has suffered through regular 10-year cycle of wildfires that have decimated the community. This has exacerbated the already poor economic conditions and public health issues in this tight knit community.

And yet, this is an area with surprising beauty and untapped recreational and community building opportunities that could center on lands already in public ownership.

Contained in this basin is a lovely 300-acre lake with clear water and a tree lined shore. Unique to many lakes at this low elevation, the management of the man-made lake means that water levels remain relatively high throughout the year. The entire shoreline is in public ownership with the Thermalito Water and Sewar District (TWSD). However, recreational opportunities are limited to a couple of parking and a short trail to shoreline fishing. There are no sanctioned trails, few amenities (no restrooms, picnic areas, trash cans, etc.). Kayaks and swimming are currently prohibited.

The Paradise Recreation and Park District (PRPD) has been a part of the community for over 50 years with 2 key community assets - swimming programs at the local school pool and a small park that just before the Camp Fire, we invested new play equipment, picnic tables, drinking water, interpretive signs, and other amenities.

Recently, TWSD and PRPD have engaged in discussions to establish a Memorandum of Understanding to explore the feasibility of recreational development with a community centered approach. The intent of the MOU will be to explore options, public access, conduct outreach, develop priorities and partnerships, for a multi-year, multi-phase recreation and management plan. We anticipate completion of the MOU later this year.

Eventually, the project could model PRPD's recent partnership with the Paradise Irrigation District, which have resulted in elevated recreation and resource management and over \$6 M in funding for recreational investments and enlightened fuels management.

The project would explore planning for a future access, trails, and paddling opportunities and linkages to other publicly owned resources and future opportunities. In addition, proper stewardship of the shoreline forest could aid in conservation and fire protection goals.

PRPD seeks funding for a well-defined planning and outreach effort to fortify this partnership and provide a pathway for successful future phases. Key tasks include:

- Inventory and mapping of lands in public ownership
- An evaluation of recreational development feasibility

- Public engagement and organizational coordination (we anticipate a high level of local and regional interest)
- Development of phases, projects, costs, and identification of funding sources for phases
- Plan for operation and future programming
- Explore educational opportunities
- Exploration of agreements or mechanisms to formalize partnerships
- Environmental compliance
- Remaining funds would be used for initial community-based volunteer efforts, funding, signage, and initial site improvements.

A Land management plan for TWSD lands, PRPD's Crain Park (approximately 450 acres), and potentially new PRPD additions to integrate management, protect resources, sustainably provide recreation, and manage fuels. The plan would also estimate costs, evaluate resources available to complete the work, and funding sources. The plan would also complement a comprehensive examination of Wildfire Risk Reduction Buffers funded through FEMA and CALOES.

Importantly, this project could provide much needed sustainable economic opportunities to an economically disadvantaged community with few options and community assets.
