#### THE POSITION

Under direct supervision of the Recreation Supervisor, Ice Rink Manager, Ice Rink Supervisor, performs work involving leadership of ice rink activities, monitoring the facility, keeping supplies and equipment in safe order, performing maintenance duties, assisting other staff as needed, and doing general program clean up as required.

#### **ESSENTIAL DUTIES**

Duties include:

- Assist in planning, organizing, and conducting ice rink activities and events.
- General help in supervision of all participants and spectators.
- Performing maintenance duties as directed.

## **ADDITIONAL DUTIES**

Duties may include, but are not limited to, the following:

- Observe necessary precaution to secure the safety of participants and spectators.
- Perform service as program or facility attendant as assigned.
- Additional duties may be required based on program requirements.
- Does related work as assigned or required.

#### DESIRED KNOWLEDGE, SKILLS, AND ABILITIES

#### Knowledge

• Knowledge of recreation services and a sincere interest towards working with people.

• Skill in providing positive and optimistic leadership.

- Ability to lead program activities and assist in discipline.

#### **QUALIFICATIONS**

## Education/Experience

- One year of leadership experience or completion of a Paradise Recreation and Park District Orientation Program.
- One year of maintenance experience or completion of a Paradise Recreation and Park District Orientation Program.

# **LICENSE AND CERTIFICATION**

Possession of, or ability to obtain and maintain throughout the duration of employment, the following:

- If required, a Class C California driver's license.
- If required, must maintain throughout the duration of employment, an acceptable driving record with five or fewer points as assigned by the Department of Motor Vehicles.
- If required, a current First Aid and CPR certificate.

## PHYSICAL ACTIVITY
